Chennai, Dec 30: A towering statue of Colombian singer Shakira was recently revealed in her birthplace of Barranquilla. The 6.5-meter bronze statue showcases her iconic hip movement, arms interlocked high, torso gracefully folded, reminiscent of her famous dance moves in the "Hips Don't Lie" music video. Shakira proudly shared the statue's unveiling and family photos on Instagram with her 90 million



followers. Attended by her parents and the city's mayor, the statue, adorned with a plaque, applauds her talents and charity work through the "Pies descalzos" foundation, promoting childhood

development. The singer recently made news with a diss track aimed at former partner Gerard Piqué and his new girlfriend, breaking 14 Guinness World Records. Following her 11-

year relationship's end in 2022, Shakira addressed a tax dispute, paying a \$7.5m (£6.5m) fine to settle allegations of \$14.5 million (£13 million) in unpaid taxes from 2012 to 2014.

Denying wrongdoing, Shakira emphasized her children's well-being, expressing they didn't want her to jeopardize herself in the fight. Her statement conveyed her commitment to resolve the matter while prioritizing her family.

the spider, the woman mentioned that her ear was bleeding, and her hearing was impaired. She sought medical attention, and the healthcare professionals prescribed a week's worth of antibiotics. Despite feeling shaken, she thought her issue was now in the past.

After some time, Wild began to feel ear pain once more, leading her to inspect her ear canal again using the Smartbud. To her dismay, the patient uncovered a menacing black mass covering the interior of her ear.

## Vande Bharat train run between Bengaluru & Coimbatore

Bengaluru, Dec 30: A trial run of Vande Bharat Express from Coimbatore in Tamil Nadu to Bengaluru Cantonment and back was conducted on Wednesday, the South Western Railway said. The train between Bengaluru and Coimbatore is likely to be flagged off on December 30 along with another Vande Bharat train from Mangaluru in coastal Karnataka to Madgaon in Goa, railway officials said.

The train left Coimbatore at 5 am and reached Bengaluru Cantonment at 10.38 am. Bengaluru Divisional Railway Manager Yogesh Mohan and other officers visited Bengaluru Cantonment and inspected the train.

The SWR said the timetable for regular service and the fare structure are under review and will be notified soon. "After flagging the two Vande Bharat trains, the details of their regular services will be announced. This way, Karnataka will get five Vande Bharat trains," a top railway official told PTI.

The other three Vande Bharat trains are Bengaluru-Dharwad, Mysuru-Chennai, and Bengaluru-Kacheguda.
